He has served with many professional and civic organizations including the Sitka Historical Society and Sitka Cultural and Historical Trust, and has been active on the Art Committee of Shee Atiká's Board.

KATLIAN BAY ROAD



In 2012 the Alaska State Legislature approved the Alaska Transportation Projects Bonds Question to be placed on the November ballot. The measure allowed for a general obligation bond to be issued for the purpose of transportation projects in the state. The bond was proposed to not exceed approximately \$454 million of which \$14 million of the total bond amount was allocated to the Katlian Bay Road. The ballot measure was approved by voters: 58% Yes and 42% No.

The purpose of the proposed Katlian Bay Road project is to provide recreational and subsistence opportunities on Baranof Island within the U.S. Forest Service Sitka Ranger District managed

lands, provide access to Native Corporation (Shee Atiká) lands, and provide access to potential new material sources on State, Federal and Native Corporation lands for possible future development.

Sitka currently has a finite road system that provides limited passenger vehicle access for recreation and subsistence activities. Furthermore, Sitka has a shortage of developable material sources for future projects on the existing road system.

Francine Eddy Jones received a NICWA **Champion for Native Children** award on April 21, 2015. The Annual NICWA Award honors an organization or individual that has made outstanding contributions to the well-being of Indigenous children in the United States or Canada. Francine was nominated for her exceptional contributions to the well-being of Indigenous children, families, and communities in the United States and Canada. Francine is also currently a Director for Shee Atika Incorporated.

Nancy Douglas received **Women of the Year** award at the Honoring Women dinner hosted by Sitkans Against Family Violence (SAFV) on April 18, 2015. SAFV has been celebrating women's achievements since 1998 by giving women an opportunity to shine at their annual Honoring Women Event. Nancy was nominated for being instrumental in getting the Sitka School District to recognize the importance of cultural programming in the classroom, both to enhance the confidence and connection of Alaska Native students and to broaden the understanding of non-Native students. Nancy currently serves on the Shee Atiká Scholarship Committee.

Kathryn (Kitty) Eddy received **Teacher of the Year** award from the National Johnson O'Malley Association (NJOMA) on March 31, 2015 at the 21st Annual National NJOMA Conference. In 1934, The Johnson O' Malley Act was enacted to direct the Department of Interior to provide assistance to Natives in the area of education. Kitty believes that developing a strong relationship with parents, making a strong connection with students and collaborating with colleagues is essential for developing strong equitable programs for our Native children. Only working together can we learn from each other and share our knowledge and wisdom, so programs for Native children become a place where students are successful. My goal each day is to instill cultural and academic skills in a nurturing environment with my students always at the forefront, said Kitty.

SHAREHOLDER COMPLETES COURSE IN NEW ALASKA NATIVE BUSINESS MANAGEMENT MINOR

Connie Beemer, Shee Aitká MBA scholarship recipient, completed the 400-level course on Native corporation business management. She learned about the unique elements of Alaska Native business operations such as 7(i) revenue sharing, 8(a) government contracting, distribution of shares, and land claims issues. “It’s time to take advantage of the opportunity to learn from those who were a part of ANCSA before it’s too late and this program provides that opportunity,” Beemer said.

The University of Alaska Anchorage College of Business and Public Policy recently launched an undergraduate minor in Alaska Native Business Management. Students who attend will learn about Alaska Native perspectives, business and organizations, indigenous leadership and more. The program is designed to train the next generation of Alaska Native leaders and prepares students for a vital segment of business in Alaska.

The program is for Natives and non-Natives. Alaska Native Corporations make up a large portion of Alaska’s workforce. If students plan to stay in Alaska the chances are high they will work for or provide services to Alaska Native Corporations. The knowledge gained can be invaluable in almost any chosen career field in Alaska.
