IN GENERAL

Three directors will be elected at the 2024 Annual Meeting and all bona fide candidates are automatically nominated. 

PART II – SHAREHOLDER RESOLUTION 2024-01

You have one vote on Shareholder Resolution 2024-01 for each share of SAI voting stock which you own.
